

### ICT INFRASTRUCTURE AND SERVICES - 2016



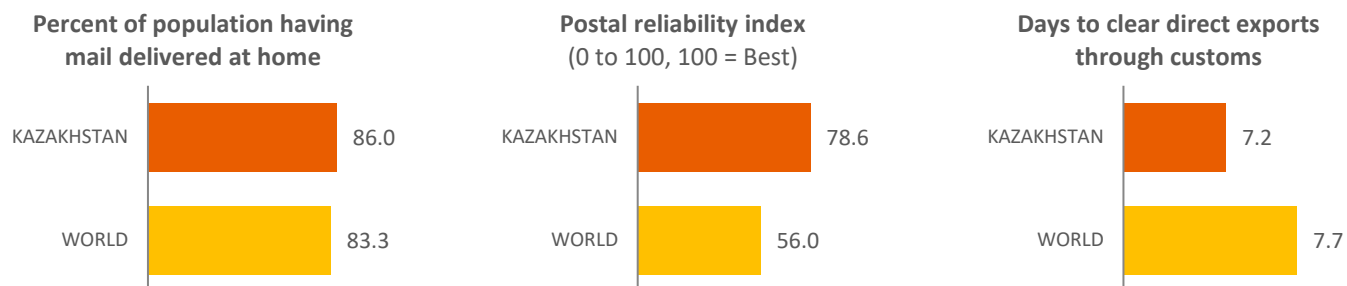

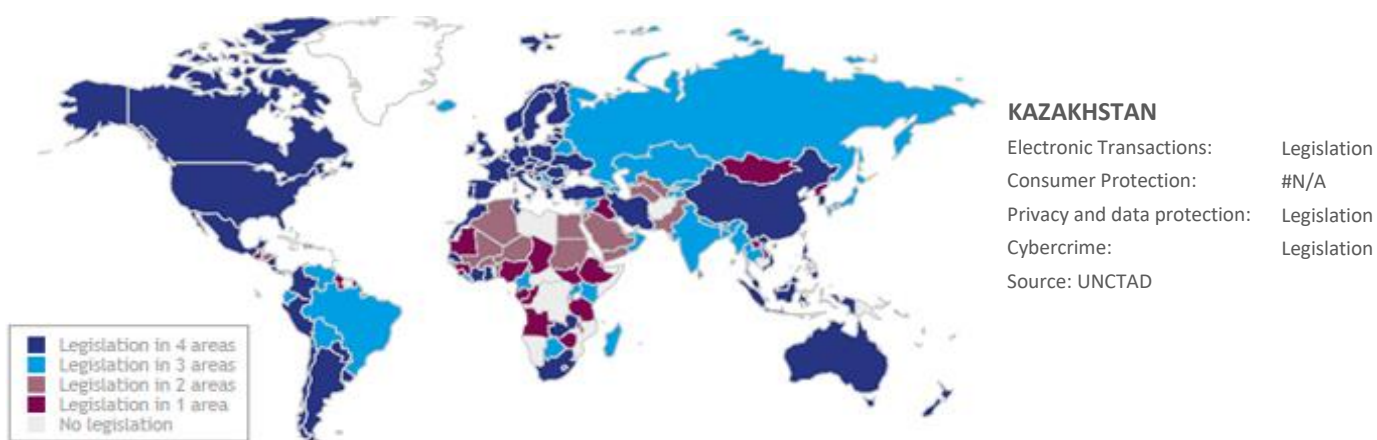

### TRADE LOGISTICS - 2016



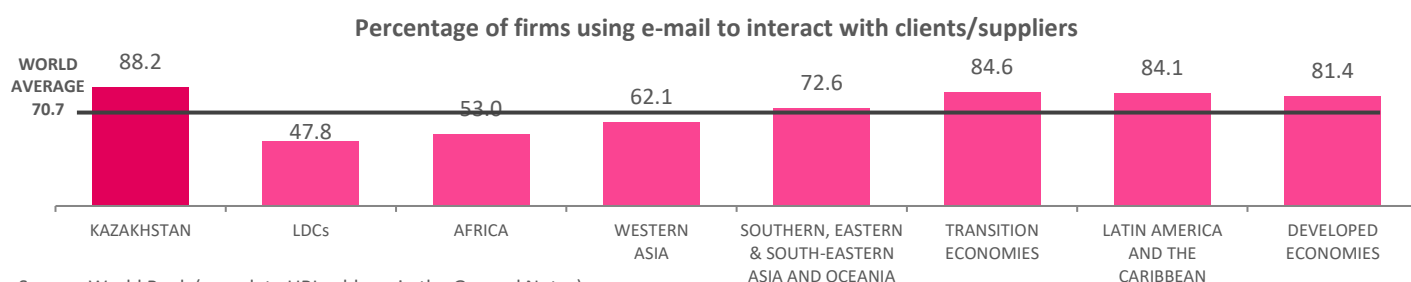

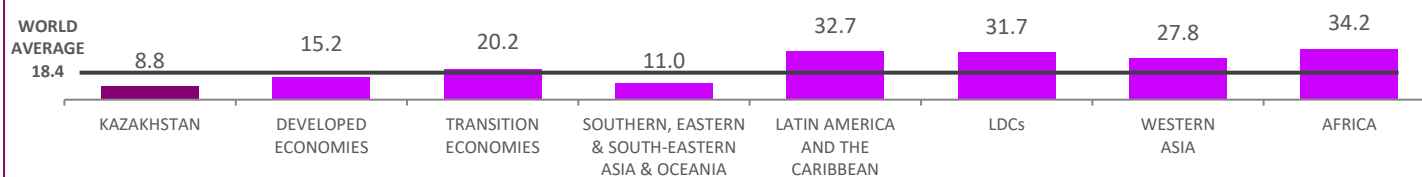
### SKILLS DEVELOPMENT - 2013-17
