



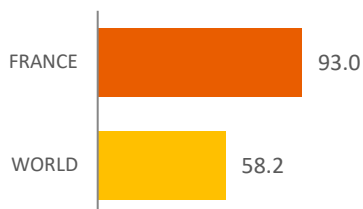

### TRADE LOGISTICS - 2013-18

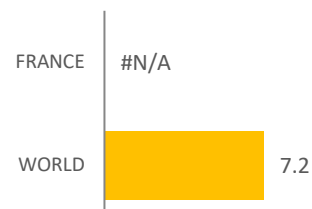
#### Percent of population having mail delivered at home

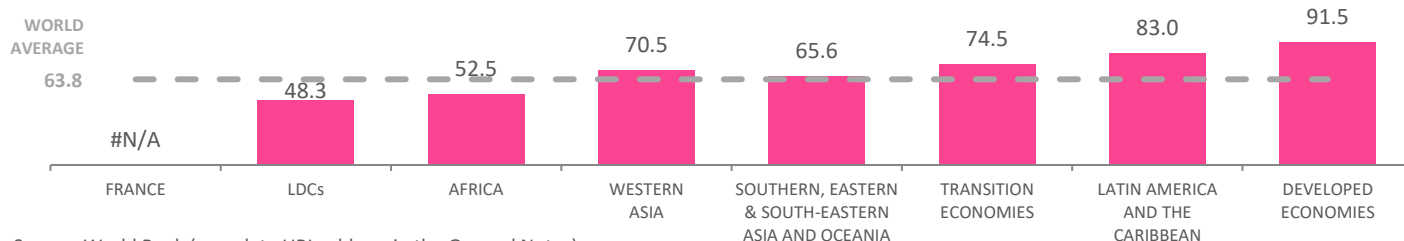

### SKILLS DEVELOPMENT - 2013-17

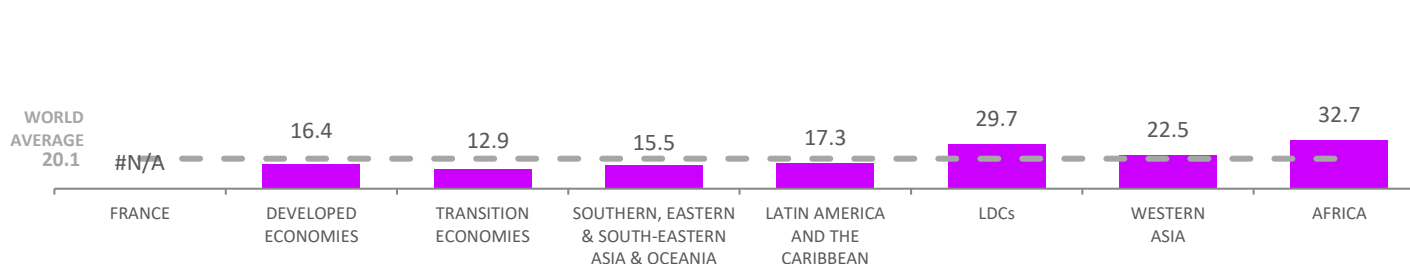
#### Percentage of firms using e-mail to interact with clients/suppliers
