



Fixed broadband Internet tariffs, PPP \$/month



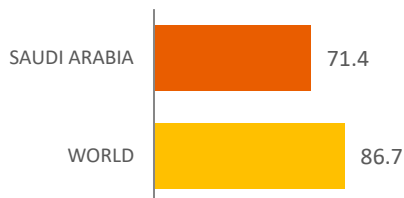

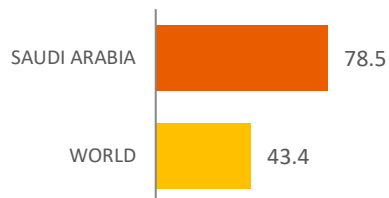

TRADE LOGISTICS - 2017-19

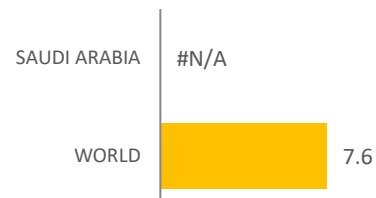
Percent of population having mail delivered at home



Postal reliability index (0 to 100, 100 = Best)

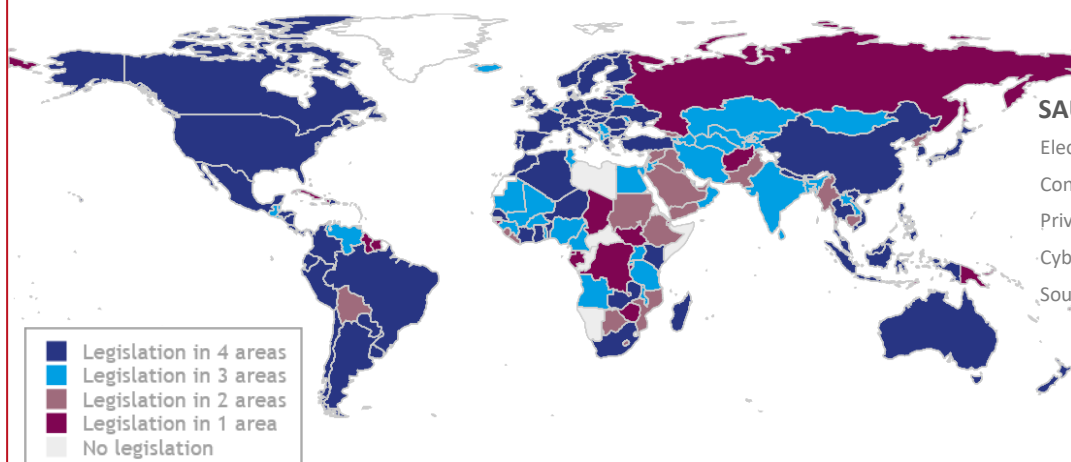


Days to clear direct exports through customs

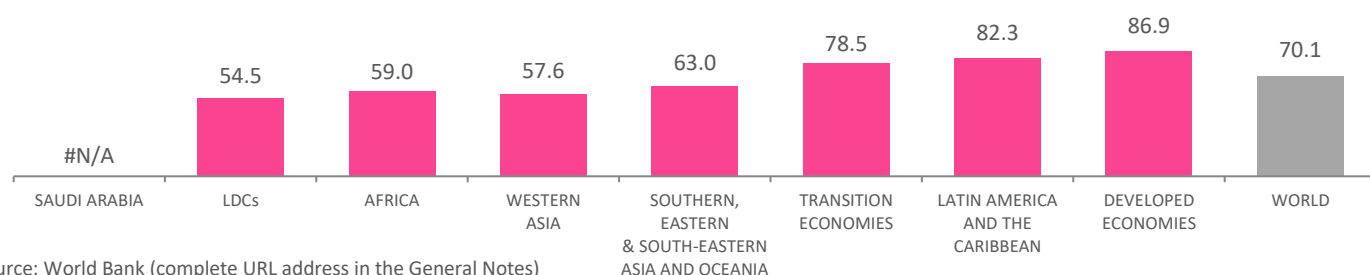
